

Agreement for Season Launch Pass

- Resident: \$50.00 – per boat/watercraft
- Non-Resident: \$70.00 – per boat/watercraft

I would like to acquire a season launch pass and agree to abide by all of the state boating regulations and any special rules for Random Lake. If I do not abide by the following rules, I understand my season pass may and will be revoked without a refund.

- All launching must be at the Lakeview Park launch site.
- All Wisconsin state boating laws (sec. 30.50-30.71) regulations must be followed.
- All boaters must abide by the controlled area regulations on Random Lake.
- All boating on Random Lake must be in a counter clock wise flow.
- Slow-no-wake for ALL is in effect from 7:00 p.m. to 10:00 a.m.
- A season pass does not eliminate any craft from the 12 boat launch limit. Park attendant will indicate when each craft can launch.
- Personal watercraft are to maintain at least 100 feet of space from other boats, water craft, piers & floating rafts or else be in slow-no-wake mode.
- Personal watercraft must also observe slow-no-wake if within 200 feet of the shoreline.
- The operator must meet the state requirements for operators.
- The Village reserves the right to revoke any/all season launch passes if Village boating/launch rules are not obeyed. No refunds.

BOATING REGULATIONS

REMEMBER:

SLOW-NO-WAKE (SNW) speed from boat launch to buoys.

Water Skiing and similar activities in counter clockwise direction only.

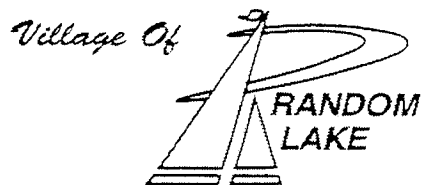
SLOW –NO-WAKE (SNW) speed from 7:00 pm to 10:00 am.

TIPS FOR PERSONAL WATERCRAFT (PWC) USERS:

1. No person may operate a PWC from sunset to sunrise.
2. No one under age 12 may operate a PWC.
3. You must wear a PFD (personal flotation device) of proper size.
4. It is illegal to operate a PWC while facing backwards.
5. There is no towing of persons engaged in water skiing, aquaplaning, or similar activities unless the PWC is designed to seat at least 3 persons.
6. PWC are restricted to slow-no-wake speed anytime:
 - ...the PWC is within 100 feet of any other boat or PWC.
 - ...the PWC is within 200 feet of the shoreline.
7. It is illegal to operate a PWC within 100 feet of the following:
 - ...another boat towing a skier or person engaging in similar activity.
 - ...the towrope of another motorboat towing a skier or person engaged in similar activity.
 - ...a person involved in skiing or similar activity.

If you see a problem situation it is suggested that you:

- Take a photo, if possible.
- Get registration number, If possible.
- Write down a description of the offending boat or PWC.
- Call police, if on duty.

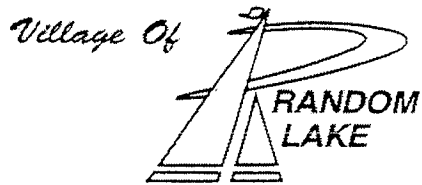
ORDINANCE #1-11
"AN ORDINANCE RESCINDING AND RECREATING SECTION 9.20 OF THE
MUNICIPAL CODE OF ORDINANCES"

The Village Board of the Village of Random Lake does ordain as follows:

Section 1. Section 9.20 of the municipal code is rescinded and recreated as follows:

9.20 BOATING REGULATIONS

1. APPLICABILITY AND ENFORCEMENT.
 - a. The provisions of this section shall apply to the waters of Random Lake.
 - b. This section shall be enforced by the designated officers of the Village and the County.
2. INTENT. The intent of this section is to provide a safe environment for the enjoyment of aquatic recreation consistent with public rights and interests and the capability of the water resources.
3. STATE BOATING AND SAFETY LAWS ADOPTED. Wisconsin state boating laws as found in Secs. 30.50 to 30.71, Wis. Stats., are adopted by reference.
4. DEFINITION. "Slow-no-wake" means that speed at which a boat, pleasure craft or personal motorized watercraft moves as slowly as possible while still maintaining steerage control.
5. CONTROLLED AREA. No person shall operate a power or speed boat, pleasure craft or personal motorized watercraft faster than slow-no-wake in the waters of Random Lake beginning south of the swimming buoys to the south shore and from the boat landing to the east limits of the swimming area adjacent to Lakeview Park.
6. LAUNCH FEE
 - a. Power and speed boats, pleasure craft and personal motorized watercraft shall be charged a launch fee as established annually by the Village Board.
 - b. These fees shall be collected either through daily payment or through purchase of a season launch pass from the Village office. The Village of Random Lake reserves the right to deny/regulate/revoke any season launch pass(es) for violation of any boating regulations set forth in Section 9.20 of the municipal code of ordinances. If said pass is revoked no refund of fee, paid at time of receiving the pass, shall be made.
7. LAUNCHING REGULATED. No power and speed boats, pleasure craft and personal motorized watercraft shall be launched anywhere but from the Lakeview Park launch site, except for lake shore property owners having access to the lake.
8. SWIMMING REGULATED. Swimming is prohibited within 100 feet of the boat launching pier and the fishing pier.



9. DIRECTION OF TRAVEL. All persons operating power and speed boats, pleasure craft and personal motorized watercraft are required to travel in a counter clockwise direction around the lake.
10. SPEED LIMITS AT CERTAIN HOURS. Slow-no-wake speed limits are required between the hours of 7:00PM and 10:00AM.
11. NUMBER OF LAUNCHINGS REGULATED. No more than 12 power and speed boats, pleasure craft and personal motorized watercraft may be launched at any time from the Lakeview Park launch site. Once the limit of 12 is reached when one craft leaves the lake, one may be launched.
12. PENALTIES. Wisconsin state boating penalties as found in Sec. 30.80, Wis. Stats., are adopted by reference.

Section 2. This ordinance shall take effect and be in force from and after its passage and publication as required by law.

The Village reserves the right to revoke any/all season launch passes if Village boating/launching rules per Vil. Ord 9.20 are not obeyed. NO REFUNDS!
